SPECIAL ORDINANCE NO. 12-11-23

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACTUAL AGREEMENT WITH MRS. FEDERICA M. SALAS FOR THE RENTAL OF THE WATER SPRING OWNED BY THE LATTER WHICH IS SITUATED AT SITIO TULALE, BARANGAY POBLACION, THIS MUNICIPALITY INCLUDING THE INFRASTRUCTURAL FACILITIES THAT MAY BE CONSTRUCTED THEREIN THAT SHALL ENSURE THE SUFFICIENT SUPPLY OF POTABLE WATER AT BARANGAYS POBLACION AND CAMPAASAN AND RATIFYING THE SAME CONTRACT

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, the Honorable Ernilo C. Villas is hereby authorized to enter into contractual agreement with Mrs. Federica M. Salas for the rental of the water spring owned by the latter which is situated at Sitio Tulale, Barangay Poblacion, this Municipality including the infrastructural facilities that may be constructed therein that shall ensure the sufficient supply of potable water at Barangays Poblacion and Campaasan and this contractual agreement is hereby ratified;




