MUNICIPAL ORDINANCE NO. 19-07-231

**AN ORDINANCE TEMPORARILY CLOSING SEVERAL PORTIONS OF
STREETS IN BARANGAY POBLACION AND CAMPAASAN,
BULALACAO, ORIENTAL MINDORO FOR REPAIR AND
REHABILITATION PURPOSES**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

Section 1. It is observed that several portions of streets in Barangays Poblacion and Campaasan are badly damaged and dilapidated that immediate repair and rehabilitation should be done to secure the safety of both the vehicles and pedestrians alike.

Section 2. The following portion of streets particularly described hereunder are hereby temporarily closed until project completion, identifying the following alternative routes for vehicles to traverse within the jurisdiction of Bulalacao, Oriental Mindoro:

- i. From Bago Street, take the route one-way to Pantilo Street going to national highway;
- ii. For those traversing Atienza Street, take the route from national highway to Pantilo Street;
- iii. In Salas Street, a portion of road from Acosta residence to Tabuk Junction which is 100 meters is closed for repair;
- iv. Montero Street is one-way going down to Salas Street;
- v. Pajado Street is one-way going up to Atienza Street to national highway;
- vi. The entire Contreras Street is two-way traffic;
- vii. Two-way traffic from Contreras Street to national highway;
- viii. Two-way traffic from terminal -Lingon Store to Public Market.
- ix. The entire Atienza Street is two-way traffic.

Section 3. Delivery trucks of six wheelers and above and all private vehicles from San Jose, Occidental Mindoro going to Mansalay and Roxas, Oriental Mindoro and vice versa shall traverse the Diversion Road;

Section 4. Delivery trucks and vans are allowed only to unload merchandise within the town proper between 8:00 p.m. to 3:30 a.m. All deliveries of merchandise during day time shall be done in the public market parking area, Barangay Campaasan.

Section 5. The Municipal Engineering Office shall post visible and clear signages to strategic areas for the information of all.


Section 6. The Bulalacao Municipal Police Station and the traffic enforcement workers are task to strictly implement this Ordinance.

Section 7. Repealing Clause. Any ordinance inconsistent with any provisions of this Ordinance is hereby repealed or modified accordingly.

Section 8. Separability Clause. If for reason any provision of this Ordinance shall be held to be invalid other provisions hereof that are not affected hereby shall continue to be in full force and effect.

Section 9. Penalty Clause. Any violation of this Ordinance shall be punishable by a fine of not more than Two thousand five hundred pesos (PhP2,500.00) or an imprisonment not exceeding six (6) months or both at the discretion of the Court.

Section 10. Effectivity. This Ordinance shall take effect at the start of the rehabilitation as fixed by the Municipal Engineering Office until further notice shall be issued by the same office.






