NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Bulalacao in session assembled that:






SECTION 2. DEFINITION OF TERMS.



- a. **Within and Cross Curriculum** - curriculum contents related to environmental awareness;
- b. **Stakeholder/s**- a group of people who will actively take part in the realization of school programs and projects;
- c. **Off-Campus**- activities conducted outside school premises;
- d. **Recreational Activities** - one of the activities initiated by any interested foundation or Organizations under Environmental Awareness for Children and Youth (EACY) Program;
- e. **Income Generating Project** - a school activity that aims to earn money to finance programs and projects;
- f. **Monitoring and Evaluation** - assessment in the implementation of all the provisions.



SECTION 3. REGULATORY PROVISIONS.



- a. Integration of the municipal ordinances within and across curriculum;

- d. Each school should initiate and carryout clean-up drives not only in schools but also in the whole community;






- e. Initiate income-generating projects utilizing recyclable materials available inside the school premises;

- g. Active involvement of school's club and organizations in environmental awareness activities;
- h. Monitoring of school curriculum shall be carried out by the school head of each respective elementary and secondary schools;
- i. Monitoring and evaluation of all the programs and projects shall be conducted every semester by the following: MENRO, SB Chairperson, Committee on Education, Culture and Arts, SB Chairperson, Committee in Environment and Natural Resources, representatives from NGO's and Public Schools District Supervisor.

First Offense - Call the attention of the school administrator and Community clean up


Second offense - Fee of Php2,000.00

Third and Succeeding Offense - Fee of Php2,500.00



SECTION 6. REPEALING CLAUSE. Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.


