RESOLUTION IN THE MATTER OF REQUESTING THE HON. THE SECRETARY OF EDUCATION, MANILA, THRU THE PROVINCIAL BOARD OF ORIENTAL MINDORO TO SET ASIDE P5,000.00 TO BE USED EXCLUSIVELY AS NATIONAL CONTRIBUTION TO THE COMMUNITY HIGH SCHOOL OF BULALACAO, PROVINCE OF ORIENTAL MINDORO:

WHEREAS, the P5,000,000.00 or so much thereof appropriated by Republic Act No. 5447, as an aid to the barrio high schools throughout the Philippines as special trust fund to be administered by the Hon. the Secretary of Education; and

REALIZING, that the proceeds of which shall be use exclusively as national contribution to all barrio high schools within the Philippines; and

CONSIDERING, that there is a Community High School in the Municipality of Bulalacao, Oriental Mindoro, needs the aid and help from the fund to be administered by the Hon. the Secretary of Education in accordance with Republic Act No. 5447; and
