RESOLVED, to approve the following Resolution:

RESOLUTION NO 50 ✓

AUTHORIZING THE MUNICIPAL TREASURER TO PURCHASE ONE UNIT OF MOTORCYCLE FOR OFFICIAL USE IN THE OFFICE OF THE MUNICIPAL TREASURER, BULALACAO, ORIENTAL MINDORO FOR COLLECTION INTENSIFICATION PROGRAM

WHEREAS, the Province of Oriental Mindoro thru the Office of the Provincial Assessor has ~~the~~ granted the Municipal Deputy Assessor of this Municipality one (1) unit of motorcycle for his Official use;

WHEREAS, the manner by which said motorcycle was made available to the Municipal Assessor was that the Province advanced the cost of said motorcycle and said amount advance is being paid thru monthly payroll deduction from the salary of the Municipal Assessor untill such time that the full amount advanced shall have been paid in full;

WHEREAS, the Office of the Treasurer is also in need of a motorcycle which will greatly help improve the Municipality's revenues to a great extend;

WHEREAS, it is lamentable to note that fifty per cent of our Barangay cannot be easily reach by collectors due to the absence of roads and the lack of land transportation willing to transport passengers as well as cargoes;

WHEREAS, this problem usually impeded collectors to reach these far flung areas because of the hardships as well as the hazards that they encounter wherein they are forced to hiked several kilometers of rugged terrain and winding roads and at times muddy especially during rainy season.

WHEREAS, the most logical way to solve this problem is to provide the Office of the Municipal Treasurer a most convenient and economical vehicle, which is the

motorcycle which could travel and traverse even on mountainous areas;

NOW, THEREFORE, resolved, as it is hereby resolved to authorize the Municipal Treasurer, this Municipality to purchase one (1) unit of motorcycle for exclusive use of his Office out of any appropriated amount or to revert any fund already appropriated but nevertheless not yet utilized for the purpose.

RESOLVED, FURTHER, that said motorcycle be eventually transformed to the Municipal Treasurer at his personal property upon paying the full amount or cost thru monthly payroll deduction payable within a period of three (3) years from the date of original purchase.

UNANIMOUSLY APPROVED.

THERE HAVING no other business to be transacted so on motion of Hon. Juanita T. Amparo, seconded by Hon. Manuel Merlin, the meeting was adjourned at 12:00 O'clock in the morning.
