The meeting was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there no objection so on motion of Hon. Perpetuo C. Cantos, seconded by Francisco J. Pandino, the minutes stands as confirmed.

The market vendors of this Municipality attended the meeting. The names of those who were not paying stall fees was read to this body. After reading, the Presiding Officer ask them to speak or voice their side why they are not paying stall fees.

Mr. Lucinio Gonzales, in answer to the question of the Presiding Officer said that the reason why they are not paying market fees, because they are warned by Jose Macaya and Eusebio Contreras, claimant of the land not to pay. Macaya even show to them the title of the land. Gonzales, further alleged that they are puzzled where to pay rentals and stall fees, to the Municipal Government, to Macaya or Eusebio Contreras. However, some of the market vendors promise to pay market fees and some remain silent.

The letters of Barangay Captain Antero Parel of Balatasan and the letter of Mr. Alex Decina of San Jose, Occidental Mindoro, as well as the letter of the Municipal Assessor of this Municipality was read to this body for comment.

The SB Recorder was ordered by this Body to transmit the three letters to the SSP Station Commander of this town, the PC Detachment Commander, the Provincial Commander at Calapan and to the Commanding Officer 262 PC Company at Pinamalayan, Oriental Mindoro for proper action.... UNANIMOUSLY APPROVED.

While the letter of Mr. Prodigal Cabagay was studied by this Body. Hon. Ulpiano C. Pandino moved and seconded by Hon. Perpetuo C. Cantos, the enactment of an appropriation Ordinance, appropriating the sum of ₱10,000.00 as Municipal counterpart to the Province for General Revision of Assesment under Section 21, of Presidential Decree 464, and Assesment Regulation No. 1-79 of the Ministry of Finance... UNANIMOUSLY APPROVED.

Section 2.-- This Ordinance shall take effect immediately upon its approval.
