ORDINANCE NO. 5 ✓

REQUIRING ALL FISH DEALERS TO PAY TO THE MUNICIPAL TREASURER OR HIS AUTHORIZED REPRESENTATIVES, THE CORRESPONDING FEES OF FRESH AND DRIED FISH AND CANS OF SALTED FISH, BEFORE TRANSPORTING SAME FROM THIS MUNICIPALITY TO OTHER MUNICIPALITIES OR TO BATANGAS AND MANILA FOR COMMERCIAL PURPOSES

WHEREAS, hundreds of kilos of fresh and dried fish and cans/bagas of salted fish were transported by Fish Dealers from this municipality to other municipalities or to Batangas and Manila for commercial purposes;

WHEREAS, in order to raise the revenue of this municipality and to regulate fees on fresh and dried fish and cans/bagas of salted fish being transported to other municipalities, the Sangguniang Bayan hereby ordains, that:
