RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND E. MARCOS, MALACANANG, MANILA FOR FINANCIAL AID FOR THE CONSTRUCTION OF PUBLIC HOSPITAL AND MARKET IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

WHEREAS, the municipality of Bulalacao has 16,942 inhabitants, and located in the Southernmost of the Province of Oriental Mindoro;

WHEREAS, this municipality has no public and private hospital and sick people is brought to Roxas General Hospital, Roxas, Oriental Mindoro, which is 46 kilometers away, for treatment;

WHEREAS, the town of Bulalacao has a small public market, which sheltered a few number of dry good stores, fish and vegetables vendors;

WHEREAS, construction of bigger public market to raise the revenue of this municipality is very essential;

WHEREAS, this municipality has a meager income hence, cannot afford to construct public hospital and market;

NOW, THEREFORE, on motion by Hon. Wilfredo F. Embile, seconded by Hon. Juan L. Salas, be it;

RESOLVED, as it is hereby resolved, to request His Excellency President Ferdinand E. Marcos, Malacanang, Manila for Financial Aid to be taken from Economic Support Fund (ESF) for the construction of public hospital and market, costing ₱1,000,000.00 and ₱2,000,000.00, respectively in the municipality of Bulalacao, Oriental Mindoro;

RESOLVED, FURTHER, that copies of this resolution be furnished His Excellency President Ferdinand E. Marcos, Malacanang, Manila for his favorable consideration...
