RESOLUTION CONCURRING THE APPOINTMENT OF NELSON S. BANTUGAN  
AS MUNICIPAL ENGINEER UNDER TEMPORARY STATUS IN THE MUNICI-  
PALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Nelson S. Bantugan, a bonafide resident of  
this municipality, Civil Engineer by profession and a Board  
Passer by virtue of R.A. 1080 has met the requirements of  
the Qualification Standards designed by the Civil Service  
Commission except the required experience of three (3) years;

"WHEREAS, said appointee with two (2) years and six (6)  
months experience to his credit, passed the screening and  
selection processes conducted by the Personnel Selection  
Board and was finally appointed as Municipal Engineer by the  
Local Chief Executive under Temporary Status last January  
9, 1995;

"WHEREAS, said appointment was submitted to the Sanggu-  
niang Bayan for concurrence in pursuance to Section 443 of  
the Republic Act No. 7160, which provides that appointments  
made by the Local Chief Executive need the concurrence of  
a majority of all the Sangguniang Bayan Members; Now there-
