"WHEREAS, the essential benefit of education should trickle down to the masses as they are protected by the Constitution for their academic rights;

Rosa, Barangay San Juan, this Municipality have to walk several kilometers in order to get elementary education while some are losing interest of enrolling which results to the high rate of illiteracy of the young people therein;



ON MOTION of Councilor Oscar C. Familara duly seconded by all members present, foregoing was . . .


