"RESOLUTION NO. 99-03-058

EARNESTLY REQUESTING THE HONORABLE GLORIA MACAPAGAL ARROYO, VICE PRESIDENT, REPUBLIC OF THE PHILIPPINES AND SECRETARY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT TO ALLOCATE THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1.5 M) TO BE USED FOR THE ANIMAL DISPERSAL PROGRAM IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, continuous increase in prices of all basic commodities adds burden for every Filipino family to cope up with their daily food consumption especially those who live below the poverty line;

"WHEREAS, cognizance of the welfare of its constituents, the Municipal Government of Bulalacao, Oriental Mindoro desires to expand the livelihood program already implemented wherein livestock raising appears to be advantageous and beneficial to these rural folks to help them generate income;


"WHEREAS, the Municipal Agricultural Office being the implementing arm of the agency on animal dispersal projects believed that the distribution of 1,500 piglets be successfully implemented through proper planning and supervision;

"WHEREAS, given an adequate financial support and enough technical information, the abovementioned project would surely redound to the socio-economic benefits of the beneficiaries; Now, therefore, be it


