
"WHEREAS, this Sanggunian taking cognizance of the abovenoted resolution has found that the same is just and of great necessity; Now, therefore, be it


School Board through the Provincial Governor, Hon. Rodolfo G. Valencia for the immediate repair and rehabilitation of two-room school building situated in that Brangay;
