REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR TO ALLOCATE ONE HUNDRED THOUSAND PESOS (P100,000.00) FROM THE PROVINCE' OF SCHOOL BOARD BUDGET FOR THE PURCHASE OF TWO (2) HECTARE OF LOT TO BE USED IN THE ESTABLISHMENT OF SOUTHERN BULALACAO NATIONAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO

"WHEREAS, education is vital to nation building as acknowledged by Section 17, Article II in the Declaration of State Policies of the 1987 Constitution which provides that the special give priority to education, Science and Technology, Arts, Culture and Sports to foster patriotism, nationalism and development. It further provides that the State shall assign the highest budgetary priority to education and that quality education be made available to all;

"WHEREAS, the Municipality of Bulalacao has but one (1) school that offers secondary school to its residents;


"WHEREAS, considering the fast growing number of population of the component barangays, this Municipality needs another secondary school;



Valencia, Provincial Governor to allocate One Hundred Thousand Pesos (P100,000.00) from the Province' of School Board Budget for the purchase of two (2) hectares of lot to be used in the establishment of Southern Bulalacao National High School , Bulalacao, Oriental Mindoro;


