EARNESTLY REQUESTING THE HONORABLE RAMON B. REVILLA, SENATE CHAIRMAN, COMMITTEE ON PUBLIC WORKS, SENATE OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1.5 M) FOR THE SPRING DEVELOPMENT AT LAGNAS, SITIO STA. ROSA BARANGAY SAN JUAN, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, water plays a vital role in sustaining man's life and preserving their good health by decreasing potential diseases that might be brought about by the lack of potable water;

"WHEREAS, there is scarcity in water supply at Sitio Sta. Rosa, Barangay San Juan, this Municipality especially during summer season wherein the residents are forced to get water from any available sources which there is no assurance of its potability;

"WHEREAS, the inadequacy of water supply in the abovementioned barangay is not due to lack of source, since there is a water source at Lagnas, Sitio Sta. Rosa, which if developed can supply sufficient potable water to the whole barangay;


"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro is financially incapable to finance the project, and hence seeking assistance to facilitate the most needed substance for human existence, Now, therefore, be it


