"RESOLUTION NO. 97-03-056

REQUESTING THE DBM SECRETARY, THE HONORABLE SALVADOR M. ENRIQUEZ, JR. TO GRANT SUPPLEMENTAL AUTHORITY TO PURCHASE IN FAVOR OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN ADDITION TO PREVIOUSLY APPROVED AUTHORITY TO PURCHASE ONE (1) UNIT OF MOTORGRADER AND ALLOCATING AN ADDITIONAL AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00)

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro has allocated the amount of One Million Two Hundred Sixty One Thousand and Forty Pesos (P1,261,040.00) for the purchase of one (1) unit of grader under Appropriation Ordinance No. 96-02-003 and Supplemental Budget No. 1, series of 1996;

"WHEREAS, that previous allocation made in the previous year for the acquisition of one (1) unit of grader became insufficient on account of the increase in price of such heavy equipment as notified by the distributor as they made the mistake in the computation, however; it appeared that such quotation was the lowest price as proved by the abstract of the quotations of canvass;


"WHEREAS, in order to augment the necessary amount for the purchase of one unit of motorgrader, the Municipal Government of Bulalacao, Oriental Mindoro further allocated an additional amount of Three Hundred Thousand Pesos (P300,000.00) passed under Sangguniang Bayan

Appropriation Ordinance No. 97-03-006 and Supplemental Budget No. 1, series of 1997; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the DBM Secretary, the Honorable Salvador M. Enriquez, Jr. for the supplemental authority to purchase in favor of the Municipality of Bulalacao, Oriental Mindoro in addition to previously approved authority to purchase one (1) unit of motorgrader and allocating an additional amount of Three Hundred Thousand Pesos (P300,000.00);






