REQUESTING THE PROVINCIAL SCHOOL BOARD THROUGH THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR TO ALLOCATE FUNDS FOR THE CONSTRUCTIONS OF THE SCHOOL CANTEEN AND GATE OF BULALACAO CENTRAL SCHOOL, BULALACAO, ORIENTAL MINDORO

"WHEREAS, education is essential to nation building as acknowledged by Section 17, Article 11 in the Declaration of State Policies of the 1987 Constitution;

"WHEREAS, in order to harness the interest of the grade school pupils, various school facilities should be provided to promote health, social and a safe environment for a more convenient and conducive learning process;

"WHEREAS, the Bulalacao Central School, Bulalacao, Oriental Mindoro is still devoid of the school canteen and gate from which the pupils can take a rest and be get assured of their safety from outsiders with malicious acts;

"WHEREAS, the provision of the school canteen and gate at Bulalacao Central School would definitely redound to the social and security benefits of the grade school pupils enrolled therein; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Provincial School Board through the Honorable Rodolfo G. Valencia, Provincial Governor to allocate funds for the constructions of the school canteen and gate of Bulalacao Central School, Bulalacao, Oriental Mindoro;
