EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE IMMEDIATE CONSTRUCTION OF THE ORCONOMA RIVER PROTECTION DIKE AT THE MUNICIPALITY OF BONGABON, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Bongabong River is a major natural landmark connecting the Municipalities of Mindoro which suffers time and again from several kinds of catastrophe caused both by man-made calamities or by force majeure;

"WHEREAS, such bridge is connected via Orconoma Bridge which serve the entire inhabitants of the Island of Mindoro;

"WHEREAS, the river banks of Bongabong River is facing possible greate damage if it shall not undergo immediate rehabilitation and the local people are afraid that the previous experiences of having to walk crossing the river with its inclement flow posing eminent danger to their lives and safety may happen again if such problem is not duly address in due time, it is incumbent naturally for the local leaders to act on certain measures that could prevent such occurrence of what considered to be a local disaster hence, such bridge must at all times be properly maintained; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Her Excellency Gloria Macapagal Arroyo, President, Republic of the Philippines to allocate the necessary funds for the immediate construction of the Orconoma River Protection Dike at the Municipality of Bongabong, Province of Oriental Mindoro;


