REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, PROVINCIAL GOVERNOR THRU THE HONORABLE TADDY VENTURANZA, VICE GOVERNOR TO FIX THE EXACT BOUNDARIES BETWEEN THE MUNICIPALITY OF CALUYA, PROVINCE OF ANTIQUE, MUNICIPALITY OF MAGSAYSAY, OCCIDENTAL MINDORO OVER THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

'WHEREAS, there exists a great need to provide clarity in the definition of territorial jurisdiction and boundaries between the Municipalities of Bulalacao, Oriental Mindoro and Magsaysay, Occidental Mindoro as well as between Bulalacao and the Municipality of Caluya, Province of Antique;


'WHEREAS, the immediate and prompt determination of the exact area of territorial jurisdiction of the Municipality of Bulalacao vis-à-vis the two mentioned municipalities from adjacent provinces deserves urgent attention in order to avoid any possible boundary disputes in the future; in fact there is already a looming one against the Province of Antique;

'WHEREAS, such determination of boundary once fixed in the very immediate future would redound greatly to the stability of economic, social and political conditions of the residents living in these three stated municipalities; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable Bartolome L. Marasigan, Provincial Governor thru the Honorable Taddy Venturanza, Vice Governor to fix the exact boundaries between the Municipality of Caluya, Province of Antique, Municipality of Magsaysay, Occidental Mindoro over the Municipality of Bulalacao, Province of Oriental Mindoro;
