"WHEREAS, the waiting shed at the abovementioned place could likewise serve as a passenger terminal catering passenger voying for San Jose, Occidental Mindoro;


"WHEREAS, such benevolence of the good governor deserves recognition and appreciation; Now, therefore, be it


