"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is located in the southernmost tip of the province, is composed of approximately 20% Hanunuo Mangyans who almost rely their basic needs to the municipal government particularly those concerning health problems;

"WHEREAS, Dr. Imelda F. Ramos, the Municipal Health Officer and Dr. Rey Asignacion, Director, Bulalacao Community Hospital are in dire need of various medical equipments necessary to expand health services and for the advance treatment of diseases;

"WHEREAS, it was a great privilege and opportunity for the people of Bulalacao when sometime in May, 2000, the Bethesda Community Outreach conducted free medical and dental treatment and medicines which benefited much of our constituents, proving the great need for additional medicines and various medical equipments to attend the medical needs of the patients;
