EARNESTLY REQUESTING THE DIRECTOR GENERAL OF THE TECHNOLOGY LIVELIHOOD RESOURCE CENTER (TLRC), MANILA TO PRIORITIZE THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE GRANT OF LIVELIHOOD PROGRAMS AND PROJECTS

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is the Pro-Poor Municipality pursuant to Executive Order No. 370;

"WHEREAS, Bulalacao is located in the southernmost tip of the Province of Oriental Mindoro and is composed of approximately 20% Hanunuo Mangyans who live below poverty line;

"WHEREAS, the Municipal Government of Bulalacao hounded with financial constraints could not readily allocate livelihood programs for each component barangays that assistance from higher government agencies is direly needed;

"WHEREAS, it is believed that given the right opportunity, enough funds, technical knowledge and skills and appropriate training on livelihood programs and projects, improve quality of life could be best achieved;


"WHEREAS, in behalf of the people of Bulalacao, this Body earnestly request the Technology Livelihood Resource Center to put-up a livelihood program to this Municipality that is believed to benefit our people; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Director General of the Technology Livelihood Resource Center (TLRC), Manila to prioritize the Municipality of Bulalacao, Province of Oriental Mindoro in the grant of livelihood programs and projects;


