RESOLUTION NO. 02-08-163

EARNESTLY REQUESTING THE HONORABLE NOLI "KABAYAN" DE CASTRO, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF FIVE MILLION PESOS (PHP5MILLION) TO BE USED FOR THE RE-GRAVELLING OF BALATASAN ROAD SITUATED AT BARANGAY BALATASAN, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was included among those towns declared as Pro-Poor Municipality pursuant to Executive order No. 370;

"WHEREAS, Bulalacao which is located in the southernmost tip of the Province of Oriental Mindoro faces an isolation among the rest of the towns due to the absence of a good and functional transportation and communication systems;

"WHEREAS, it is always believed that the construction and rehabilitation of farm to market roads particularly the Balatasan Road at this Municipality would speed-up the socio-economic development of the place for shipment of various agricultural and marine products be made easier;


"WHEREAS, the Balatasan Road remains unpassable during rainy season that there is a need to re-gravel it in order to boost the Balatasan Cove which was declared as Tourists Spot Reserves by virtue of proclamation No. 1801;

"WHEREAS, it is learned that the priority programs of Senator Noli "Kabayan" de Castro is the construction of farm to market roads that the Municipality of Bulalacao wish to be included and prioritized for the welfare and benefits of its people; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED; To: Earnestly request the Honorable Noli "Kabayan" de Castro, Senator, Republic of the Philippines to allocate the amount of Five Million Pesos (PHP5Million) to be used for the re-gravelling of Balatasan Road situated at Barangay Balatasan, Municipality of Bulalacao, Province of Oriental Mindoro;


