"WHEREAS, the Island of Liwagao at the Municipality of Bulalacao, Province of Oriental Mindoro was included in the eleven (11) Tourist Spot Reserves declared under Proclamation No. 1801;


"WHEREAS, it is understand that boosting the tourism industry was one of the priority programs of the National Government that every effort should be *exerted* to protect and preserve the natural beauties of the country in order to help achieve social and economic stability;
