**EARNESTLY REQUESTING THE HONORABLE MARITA M. JIMENEZ, CABINET ACTION OFFICER FOR ORIENTAL MINDORO AND CAVITE TO INTERCEDE IN THE ALLOCATION OF FUNDS FOR THE CONCRETING OF BULALACAO-MAGSAYSAY NATIONAL HIGHWAY, A CIRCUMFERENTIAL ROAD CONNECTING THE PROVINCES OF ORIENTAL AND OCCIDENTAL MINDORO**

“WHEREAS, it is happy to see that passenger jeepneys and other kinds of vehicles are traversing along the Bulalacao-Magsaysay National Highway, a circumferential road connecting the Provinces of Oriental and Occidental Mindoro for it facilitate the movement of people and shipment of goods;

“WHEREAS, it is believed that the opening-up of the circumferential road mentioned above would trigger economic activities of both provinces, encourage more investments, create jobs, develop a good social and economic relationships, promote and enhance mutual understanding and cooperation to the benefits of their people;


