**RESOLUTION NO. 02-06-136**

**EARNESTLY REQUESTING THE CHAIRMAN, NATIONAL POWER CORPORATION (NAPOCOR) TO ESTABLISH A WINDMILL POWERED ELECTRICITY AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

“WHEREAS, the Municipality of Bulalacao which is located in the southernmost tip of the Province of Oriental Mindoro was declared as a Pro-Poor Municipality pursuant to Executive Order No. 370;

“WHEREAS, Bulalacao faces an isolation among the rest of the towns due to the absence of a good communication and transportation insufficiency in power supply which causes frequent brown-outs;

“WHEREAS, insufficiency of electricity hindered the present Administrations' program of rural electrification that a windmill powered electricity is seen to be the best alternative for the rural folks to enjoy the light at nighttime at no cost;


“WHEREAS, considering that Bulalacao has high mountain ranges a windmill powered electricity is believed to be practical and feasible; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Chairman, National Power Corporation (NAPOCOR) to establish a windmill powered electricity at the Municipality of Bulalacao, Province of Oriental Mindoro;






