RESOLUTION NO. 02-06-122

EARNESTLY REQUESTING THE HONORABLE LEONARDO Q. MONTEMAYOR, SECRETARY, DEPARTMENT OF AGRICULTURE TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF FARM TO MARKET ROADS FROM BARANGAY SAN FRANCISCO-SAN ISIDRO TO CABUGAO AND FROM BARANGAY BENLI TO BAILAN-UMABANG TO BARANGAY CAMBUNANG ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 1, Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the Nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;

"WHEREAS, the Municipality of Bulalacao faces an isolation among other towns in the Province of Oriental Mindoro due to the absence of a functional communication and transportation systems;

"WHEREAS, the construction of farm to market roads at the Municipality of Bulalacao would lead to an easier shipment of various agricultural and marine products, enhance the value of these produce and open the floodgates for further development;

"WHEREAS, the realization of the abovementioned request would definitely push the implementation of programs that shall geared towards the development and empowerment of our brothers and sisters in the countrysides;

“WHEREAS, it is strongly believed that Secretary Montemayor would give priority to the Municipality of Bulalacao in the implementation of farm to market roads since he personally visited this town and see for himself the dire need of a passable roads to mobilize people and resources to achieve social and economic development; Now, therefore, be it


