“WHEREAS, the Senior Citizens Federation of the Municipality of Bulalacao, Province of Oriental Mindoro wishes to establish a Bigasang Bayan to facilitate the sufficient supply of rice at an affordable price to its members during rainy season where rice hoarding is rampant;


