EARNESTLY REQUESTING THE REGIONAL DIRECTOR, REGION IV-B, PHILIPPINE PORTS AUTHORITY (PPA) TO ALLOCATE FIVE MILLION PESOS (PHP5M) FOR THE COMPLETION OF BULALACAO MUNICIPAL PORT, BULALACAO, ORIENTAL MINDORO

"WHEREAS, it has been arduous desire of the Municipality of Bulalacao, Province of Oriental Mindoro to improve its temporary landing area through the construction of a permanent port to serve the incoming and outgoing cargoes, passenger and fishing boats;

"WHEREAS, the Municipality of Bulalacao is primarily engaged in fishing industry producing large volume of marine products shipped to Cavite and Manila but sad to say, lacks the necessary support facility such as that of a permanent port where loading and unloading of fish caught be safely and properly done;


