**ORDINANCE NO. 08 - 07- 85**

**DECLARING THE ACCESS ROAD FROM THE PROVINCIAL ROAD GOING TO BULALACAO PUBLIC MARKET ONE WAY FOR ALL TYPES OF VEHICLES**

**Sponsor: Councilor Leonardo A. Andallon**  
**Chairman: Committee on Public Utilities and Facilities**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The access road from the Provincial Road going to Bulalacao Public Market is hereby declared one way for all types of vehicles;

**SEC. 2.** All types of vehicles going to the Bulalacao Public Market must take the access road as an entrance;

**SEC. 3.** The one way traffic declared herein must be strictly observed and followed twenty four hours (24) a day everyday;


**SEC. 4. PENALTY.** Any violation of this Ordinance shall be punished by a fine of not exceeding Two Thousand Five Hundred Pesos (Php2,500.00) or by an imprisonment for a period of not more than six (6) months or both such fine and imprisonment at the discretion of the Court;


**SEC. 5. EFFECTIVITY.** This Ordinance shall take effect immediately.
