APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2005 OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF FOUR HUNDRED THIRTY TWO THOUSAND THREE HUNDRED SEVENTY PESOS AND TWENTY TWO CENTAVOS (PHP432,370.22) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1 CY 2005 DATED FEBRUARY 7, 2005

"WHEREAS, Section 57 and Section 447 par (ii) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;



"WHEREAS, the Barangay Fund Annual Budget for FY2005 of Barangay Maasin was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on March 11,2005 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be reallocated to any other projects; **WHEREAS**, it is hereby recommended that the proposed budget shall be guided by existing COA rules and regulations. 




