**RESOLUTION NO. 05-02-036**

**RESOLUTION APPROVING THE DEFERMENT OF A PORTION OF ITS INTERNAL REVENUE ALLOTMENT (IRA) CORRESPONDING TO THE INCREASE FROM ITS 2005 SHARE, EXCEPT FOR THE AMOUNT OF ONE MILLION PESOS (PHP1,000,000.00) WHICH SHALL BE USED FOR INFRASTRUCTURE PROJECTS, AND FOR OTHER PURPOSES**

**"WHEREAS**, the League of Municipalities of the Philippines (LMP), at the meeting of the members of its National Directorate in Cebu City on 21<sup>st</sup> October 2004, passed and approved National Directorate (ND) Resolution No. 006-2004 proposing measure to assist the national government in its bid to improve the country's fiscal situation;

**"WHEREAS**, a proposal embodied in National Directorate (ND) No. 006-2004 is for member municipalities of the LMP to agree to the deferment of the release of the increase in their Fiscal Year 2005 IRA shares, provided that the National Government shall still release the amount of One Million Pesos (PHP1,000,000.00) out of such IRA increase;

**"WHEREAS**, this Municipality concurs with National Directorate (ND) Resolution No. 006-2004 and supports the ten (10) point legacy agenda of President Gloria Macapagal-Arroyo; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Adopt ND Resolution No. 006-2004 by approving the deferment of a portion of its Internal Revenue Allotment (IRA) corresponding to the increase from its 2005 share, except for the amount of One Million Pesos (PHP1,000,000.00) which shall be used for infrastructure projects, and for other purposes;

**RESOLVED FURTHER**, that for this purpose, the Department of Budget and Management is hereby authorized to defer and withhold the release of the FY 2005 increase in IRA of the Municipality, except for the amount of One Million Pesos which shall be immediately released,


**RESOLVED ALSO**, the aforementioned amount of One Million Pesos shall be earmarked and used for the implementation of Municipality's priority and much needed infrastructure programs/projects, as follows: (1) concreting of unpaved municipal roads, (2) concreting of access roads to public markets, and (3) concreting of barangay roads accessible to at least two barangays;


