ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO ALLOCATE THE AMOUNT OF FIVE MILLION PESOS (PHP5M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM SAN ROQUE TO SITIO LIBTONG, BARANGAY SAN ROQUE, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
