UMALI, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO ALLOCATE THE AMOUNT OF SIXTY MILLION PESOS (PHP60M) TO BE USED FOR THE ROAD OPENING AND CONCRETING STARTING FROM SITIO SIBUCAO, BARANGAY CAMPAASAN TO RORO PORT SITUATED AT SITIO KAWAYAN, BARANGAY POBLACION, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
