**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**"WHEREAS**, Bulalacao is a third-class Municipality located at the southernmost tip of the Province of Oriental Mindoro, it has a municipal government that aims to provide efficient water system that provides potable water supply regularly to its people;

**"WHEREAS**, the islands of Suguicay in Barangay San Juan and Buyayao in Barangay San Roque are remote areas and distantly situated from the mainland of the Municipality of Bulalacao, thus, both have limited sources of potable water supply that obtain inconvenience to the daily living of its residents;


“WHEREAS, water desalination is a technology that enhance the process of removal of salts and minerals to produce safely managed water suitable for human consumption such as drinking that is free from contamination;


