RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO THRU GOVERNOR HUMERLITO "BONZ" A. DOLOR TO GRANT 3 UNITS OF KAYAK AND 3 UNITS OF SWAN BOAT WHICH WILL BE USED BY THE SANGGUNIANG BARANGAY OF POBLACION, ORIENTAL MINDORO IN ITS TOURISM-RELATED ACTIVITIES ALONG KABURAYAN RIVER AND IN LOBOC HISTORICAL/ARCHEOLOGICAL RUINS

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;
