RESOLUTION INTERPOSING STRONG OBJECTION TO THE APPLICATION OF WHOEVER PRIVATE INDIVIDUAL FOR MANGROVE FOREST LEASE AGREEMENT IN SUGUICAY ISLAND, BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO THAT MAY BE SUBMITTED TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) THRU THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) OR TO THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (PENRO) AND EXPRESSING OBJECTION TO ANY POSSIBLE EXTENSION THEREOF

"WHEREAS, it is made known to this Body that the Mangrove Forest Lease Agreement in the Island of Suguicay presently occupied by a certain private individual will come to an end soon as stipulated in the contract and agreed upon by both parties;

"WHEREAS, the importance of mangrove trees in our ecosystem for the propagation of fish and other huge varieties of marine life is indispensable that proper care and management should be undertaken to ensure its sustainability not only for the present but for the future use;

"WHEREAS, this Sanggunian believes that the Mangrove Forest Lease Agreement at Suguicay Island is best to be awarded to the Local Government Unit of Bulalacao or to any interested and qualified non-government organization instead of, to a private individual whose mindset and purpose is to commercially use the area in exchange of profit; **Now, therefore, be it**


