RESOLUTION NO. 17-06-148

RESOLUTION REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE TO ALLOCATE A PARCEL OF LAND FROM THE COMMONWEALTH LOT SITUATED IN BARANGAY CAMBUNANG, BULALACAO ORIENTAL MINDORO TO BE USED AS SCHOOL SITE FOR THE PROPOSED BULALACAO NATIONAL HIGH SHOOOL, CAMBUNANG ANNEX AND FURTHER REQUESTING TO EXEMPT THE SAME LOT FROM APPICATION OF PRIVATE PERSONS.

WHEREAS, it is a constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all;

WHEREAS, in support to the abovementioned Constitutional mandate, the Local Government Unit of Bulalacao exerted efforts for the establishment of new secondary schools particularly in far-flung barangays in order to provide enough opportunities to students to get secondary education at their convenience and at minimum cost;


WHEREAS, the proposed Bulalacao National High School, Cambunang Annex shall cater elementary graduates from Cambunang Elementary School and nearby elementary schools that shall socially and economically benefit both parents and students alike;

WHEREAS, according to studies, the only available lot which could be used as school site is from the Commonwealth lot in Barangay Cambunang, so that this resolution is passed in order to inform and request the Community Environment and Natural Resources Office (CENRO) to reserve certain area needed to realize the establishment of the herein mentioned secondary school;

RESOLVE AS IT IS HEREBY RESOLVED, To: Request the Community Environment and Natural Resources office to allocate a parcel of land from the Commonwealth lot situated in Barangay Cambunang, Bulalacao Oriental Mindoro to be used as school site for the proposed Bulalacao National High School, Cambunang Annex and further requesting to exempt the same lot application of private persons;






