RESOLUTION RECOMMENDING TO THE MUNICIPAL MAYOR THE APPROVAL OF THE CONVERSION OF SAN ROQUE – BANGKAL – TAFARMA – SINARAYAN BARANGAY ROAD INTO SAN ROQUE – BANGKAL – TAFARMA – SINARAYAN PROVINCIAL ROAD IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, Provincial Ordinance No. 66-2017, series of 2017 sets certain guidelines and requirements in the conversion of barangay roads into provincial roads;

“WHEREAS, San Roque – Bangkal – Tafarma – Sinarayan Barangay Road starting from Barangay San Roque Junction, National Highway is passable for at least five (5) years, connecting an existing provincial road the national highway within the territorial boundaries of the province;

“WHEREAS, that road is traversing Barangays San Roque, San Juan, and Nasucob all of which are engaged in agriculture and fishing industries and as such an all-weather road network is indispensable to support economic activities, delivery of social services, and the attainment and maintenance of peace and order, development, and progress;

"WHEREAS, taking into consideration the guidelines enumerated in Provincial Ordinance No. 66-2017, the barangay road mentioned above is recommended to be converted into a provincial road; Now, therefore, be it


