RESOLUTION NO. 21-02-062

EARNESTLY REQUESTING HIS EXCELLENCY RODRIGO ROA DUTERTE THRU THE DEPARTMENT OF BUDGET AND MANAGEMENT TO EXPEDITE THE RELEASE OF ADDITIONAL INTERNAL REVENUE ALLOTMENT (IRA) TO THE LOCAL GOVERNMENT UNITS PURSUANT TO MANDANAS RULING IN ORDER TO MITIGATE THE EFFECT OF ECONOMIC RECESSION

“WHEREAS, on January 10, 2012, then Congressman Hermilano I. Mandanas as lead petitioner and in representation of local government units filed a petition in the Supreme Court docketed as SC-G.R. No. 199802 against the National Government (NG) seeking the automatic release of the LGUs full share of the government taxes known as the Internal Revenue Allotment (IRA) as provided for in the Constitution and Laws;

“WHEREAS, the NG is in the process of negotiating the full implementation of the decision of the Supreme Court in the said case;

“WHEREAS, the eventual release of the said IRA subject of the aforementioned case will enable the LGU to hasten delivery of such needed services to its constituents such as education, livelihood and environmental protection, housing, roads and bridges, water system, health care services and disaster preparedness and mitigation among others;

“WHEREAS, the full and immediate release of IRA will strengthen local autonomy and help every LGU recover from the quagmire of losses and emptiness brought by covid-19 pandemic; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request His Excellency Rodrigo Roa Duterte thru the Department of Budget and Management to expedite the release of additional Internal Revenue Allotment (IRA) to the Local Government Units pursuant to Mandanas Ruling in order to mitigate the effect of economic recession;




