RESOLUTION NO. 20-06-278

EARNESTLY REQUESTING HONORABLE SHERWIN T. GATCHALIAN, SENATOR, REPUBLIC OF THE PHILIPPINES TO PROVIDE THE NECESSARY INTERVENTION FOR THE APPROPRIATION OF FUNDS FOR THE CONSTRUCTION OF 12-CLASSROOM 2-STOREY BUILDING IN BULALACAO CENTRAL SCHOOL, 4-CLASSROOM BUILDING IN SAN JUAN ELEMENTARY SCHOOL, AND 3-CLASSROOM BUILDING IN SAN VICENTE ELEMENTARY SCHOOL, ALL IN BULALACAO, ORIENTAL MINDORO

"WHEREAS, pursuant to Republic Act No. 9155 also known as the Governance of Basic Education Act, the Department of Education (DepEd) was vested with the authority, accountability and responsibility of ensuring access, promoting equity, and improving the quality of basic education;

"WHEREAS, the present administration is focused to expand access to decent basic education and to enhance the current educational system as a means of reducing poverty and improving national competitiveness;

"WHEREAS, the oversized classes found in public schools violate the Constitutionally-guaranteed right of Filipino school children to quality education and the right of teachers to just compensation and humane working conditions, thus to negate these circumstances there should be enough classrooms for every public schools to sustain the teaching capacity based on the teacher-student ratio;

"WHEREAS, Bulalacao Central School is lacking of sturdy and calamity-resilient classrooms as 9 of its classrooms are housed in old, dilapidated, and damaged Marcos-type building; San Juan Elementary School has no functional school building constructed by the Department of Education; and San Vicente Elementary School has been using make-shift school building to accommodate its pupils;

"WHEREAS, pursuant to Executive Order No. 370 the Municipality of Bulalacao is considered as a 3rd class municipality hounded with financial constraints, it is located at the southernmost tip of the Province of Oriental Mindoro and according to the 2015 census it has a population of 39,107 people where almost 25 percent of it are indigenous people called Hanunuo-Mangyans;

"WHEREAS, the Bulalacao Central School was built in 1920 with its pioneering name, Bulalacao Elementary School, most of its school buildings are old and in need of reconstruction and as the number of enrollees are massively increasing every year, it would be beneficent to have additional classrooms not only in the Bulalacao Central School but also to its other branches within the municipality. **Now, therefore, be it;**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Honorable Sherwin T. Gatchalian, Senator, Republic of the Philippines to provide the necessary intervention for the appropriation of funds for the construction of 12-classroom 2-storey building in Bulalacao Central School, 4-classroom building in San Juan Elementary School, and 3-classroom building in San Vicente Elementary School, all in Bulalacao, Oriental Mindoro.
