RESOLUTION NO. 18-11-265

EARNESTLY REQUESTING THE DEPARTMENT OF HEALTH THROUGH SECRETARY FRANCISCO DUQUE FOR THE IMMEDIATE ISSUANCE OF PERMIT TO CONSTRUCT A NEW RURAL HEALTH OFFICE II WITH BIRTHING FACILITY IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Philippine Health Agenda (PHA) aims to (1) ensure the best health outcome for all, without socio-economic, ethnic, gender and geographic disparities, (2) promote health and deliver health care through means and respect, value and empower clients and patients as they interact with the health system and (3) protect all families especially the poor, marginalized and vulnerable against the high cost of health care; o

"WHEREAS, the Department of Health through Health Facility Enhancement Program (HFEP) continue to upgrade government health care facilities including barangay health stations, rural health units, district hospitals, provincial hospitals and DOH retained hospitals and other health facilities where the Municipality of Bulalacao, Province of Oriental Mindoro is fortunate to benefit the program;

"WHEREAS, the amount of Ten Million Pesos (PhP10M) is provided in the General Appropriation Act of 2018 under the DOH Health Facilities Enhancement Program for comprehensive release;

"WHEREAS, the construction of new Rural Health Office II with birthing facility shall cater the health care services; to wit:

1. Maternal and Newborn Health Service
 - a. Pregnancy tracking
 - b. Prenatal services
 - c. Birth Preparedness plan and referral
 - d. Nutrition promotion and assessment
 - e. Safe labor and delivery
 - f. Postpartum care
 - g. Basic Emergency Obstetric and Newborn Care
 - h. Referral Services

2. Child Health
 - a. Growth monitoring for identified undernourished children
 - b. Promotion of infant and young child feeding
 - c. Expanded Program on immunization
 - d. Integrated Management of Childhood Illnesses
 - e. Micronutrient supplementation
 - f. Referral services

3. Family planning
 - a. Family planning promotion
 - b. Counseling
 - c. Provision of commodities
 - d. Referral services

4. Adolescent Sexual and Reproductive Health
 - a. Youth-friendly services
 - b. Promotion of ASRH (Inc. HIV, STI, Gender Based Violence)
 - c. Counseling on prevention of teenage pregnancies
 - d. Counseling for unintended pregnancies
 - e. Referral services

5. Oral Health
 - a. Oral Hygiene Promotion
 - b. Oral prophylaxis
 - c. Management of Dental Care
 - d. Tooth Extraction
 - e. Referral Services

6. Communicable Disease
 - a. Active case finding for TB
 - b. Surveillance and reporting for notifiable disease
 - c. Management and control of TB
 - d. Management and control of the diseases with endemic potential
 - e. Referral services

7. Non-Communicable Disease
 - a. IEC against NCD risk factors
 - b. Healthy lifestyle program
 - c. Routine screening for risk factor identification
 - d. Referral for Diabetes and Hypertension
 - e. Referral services


8. Environmental Health and Sanitation
 - a. Promoting water quality and food safety
 - b. Vector control and waste management
