RESOLUTION RECOMMENDING TO THE MUNICIPAL MAYOR THE ESTABLISHMENT AND OPERATION OF MAX FM 107.3 IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, the prime purpose of a radio is to convey informations from one place to another through the interviewing media such as air, space or non-conducting materials without wires. Besides being used for transmitting sound and television signals, radio is used for the transmission of data in coded form;

"WHEREAS, radio is ideal for low-income populations and sparsely populated areas like Bulalacao since radios are affordable and broadcasts can reach a wide audience;

"WHEREAS, MAX FM 107.3 under Subic Broadcasting Corporation (SBC) through its Station Manager, Mr. Anndee Christian L. Tumulak expressed its intention to establish and operate an FM Station at this Municipality as reflected in his letter dated January 25, 2019;

"WHEREAS, upon study and review of the abovementioned request, the Committee on Public Utilities and Facilities chaired by Councilor German S. Acosta favorably recommends to the Municipal Mayor that MAX FM 107.3 be allowed to operate under certain conditions that the programs should focus only on business advertisements, entertainment, public service, lost and found section, reports and updates during calamities and disaster, political advertisements and announcement of cellphone numbers are strictly prohibited; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Recommend to the Municipal Mayor the establishment and operation of MAX FM 107.3 in the Municipality of Bulalacao, Oriental Mindoro;




