MAUJAO, BULALACAO, ORIENTAL MINDORO TO AUGMENT TRAVELLING EXPENSES FORTY TWO THOUSAND PESOS (PhP42,000.00) AND FIDELITY BOND TEN THOUSAND PESOS (PhP10,000.00) OF BARANGAY MAUJAO, BULALACAO, ORIENTAL MINDORO" OPERATIVE IN ITS ENTIRETY
