### RESOLUTION NO. 18-04-063

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2018 OF BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF TWO MILLION THREE HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED PESOS AND FIFTY NINE CENTAVOS (PHP2,378,400.59) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2018-001 DATED OCTOBER 5, 2017

**"WHEREAS**, Section 57 and Section 447 par (ii) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of Milagrosa, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2018 showing therein the sources of income and barangay expenditures starting from January 1, 2018 up to December 31, 2018;

**"WHEREAS**, the Barangay Fund Annual Budget for FY 2018 of Barangay Milagrosa was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on April 6, 2018 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be fully implemented and should not be realigned to any other projects;

"WHEREAS, Local Budget Memorandum No. 75-A clarifies that the Internal Revenue Allotment (IRA) of Barangay Milagrosa is Two Million Two Hundred Ninety Eight Thousand Seven Hundred Seventy Eight Pesos (PhP2,298,778.00), hence, necessary adjustment conforming to such amount must have to be undertaken;

"WHEREAS, Sangguniang Barangay of Milagrosa, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulation; Now, therefore, be it
