RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE LOCAL GOVERNMENT UNIT OF BULALACAO TO ENTER INTO A CONTRACT OF LEASE WITH MS. MATILDE C. SILANG ALLOWING THE LGU BULALACAO TO USE A RESIDENTIAL LOT SHE OWNED SITUATED IN BARANGAY CAMPAASAN WHICH SHALL BE USED EXCLUSIVELY AS THE LOADING AND UNLOADING AREA FOR PUBLIC VEHICLES IN CONSIDERATION OF THE MONTHLY RENTAL RATE OF FOUR THOUSAND PESOS (Php4,000.00)

Silang allowing the LGU Bulalacao to use a residential lot she owned situated in Barangay Campaasan which shall be used exclusively as the loading and unloading area for public vehicles in consideration of the monthly rental rate of four thousand pesos (Php4,000.00);

RESOLVED FURTHER, That: Any change or alteration in the Contract of Lease originally presented shall have no effect and therefore null and void;


RESOLVED FINALLY, That: Any legal encumbrance that may arise in the execution and actual application of this Contract of Lease shall be the sole responsibility of the heads of Implementing Offices or Units;


