RESOLUTION NO. 20-01-027

EARNESTLY REQUESTING THE UCPB SAVINGS BANK, CALAPAN CITY THROUGH ITS MANAGER, SIR RANDY TULAGAN TO GRANT A THREE (3) MONTHS MORATORIUM ON LOAN AMORTIZATION OF ALL MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO DUE TO DEVASTATION CAUSED BY SUPER TYPHOON URSULA

“WHEREAS, on December 3, 2019, the Municipality of Bulalacao, Province of Oriental Mindoro was hit by Typhoon Tisoy under Storm Signal No. 3 which brought havoc to the residents because it ruined residential houses and destroyed agriculture, livestock and fishing industries;

“WHEREAS, after three weeks, on Christmas Day to be exact, Bulalacao was again hit by Typhoon Ursula which was initially announced to be Storm Signal No. 3 but it was not, because it was a super typhoon which brought strong winds and heavy rains to the entire municipality which lasted for almost four (4) hours wherein an estimated 90% of residential houses and other infrastructural facilities such as roads and bridges were washed-out, 4 persons died and 4 were injured resulted to social and economic turmoil among the residents particularly the poor and the helpless families who were heavily affected by this natural calamity;

“WHEREAS, various infrastructural facilities were devastated, electricity was totally shut-down and so as the communication network and the water supply system, hospitals and school buildings were ruined and dilapidated, including the roro port and the public market, and what is more pitiful is the 90% total destruction of residential houses;

...WHEREAS, this melancholic situation suffered by the Bulalacaoons
Christmas day brought deep feelings of grief and misfortune however, with
God's graces together with the kindness and helping hands of those with
beautiful hearts, it is with high hope that residents herein could survive and
restore to its normal living condition soon;

"WHEREAS, to acknowledge a debt of gratitude to UCPB Savings
Bank for its kindness and generosity of granting a three (3) months moratorium
on loan amortization of municipal officials and employees of the Local
Government Unit of Bulalacao, let be assured that monthly loan amortization
be regularly deducted from the payroll after the moratorium in full amount;




