EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO THROUGH GOVERNOR HUMERLITO "BONZ" A. DOLOR TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF BAY PARK AND SEAWALL IN BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO AND TO FACILITATE THE INCLUSION OF THE SAME IN THE ANNUAL INVESTMENT PROGRAM (AIP), LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) AND COMPREHENSIVE DEVELOPMENT PLAN (CDP) OF THE PROVINCE

"WHEREAS, Barangay Milagrosa, Bulalacao, Oriental Mindoro is a coastal barangay whose main source of income of the residents is fishing;

"WHEREAS, coastal management needs to be prioritized and one important and identified project is the construction of bay park and seawall which is effective to protect infrastructure, houses and other establishments along seashores against erosion caused by waves and storms;

**"WHEREAS**, the Municipality of Bulalacao hopes for the financial assistance from the Provincial Government to realize the most needed projects that shall uplift the social and economic benefits of the people and the community; **Now, therefore, be it**
