CONSTRUCTION OF FARM TO MARKET ROAD FROM SITIO LIDONG TO
SITIO BURIN-AY, BARANGAY CABUGAO, MUNICIPALITY OF

"WHEREAS, a farm to market road a ranch to market road is one that connects rural or agricultural areas to market towns. There are better quality roads, usually a highway that farmers and food growers use to transport products to market towns or distribution center;

"WHEREAS, pursuant to Administrative Order No. 16, series of 2020, the Department of Agriculture (DA) is mandated to undertake various infrastructure projects such farm to market roads among others in order to provide better opportunities to farmers by increasing farm production at lower cost and thereby increasing their income and making food more affordable to the general public;

"WHEREAS, in view of this mandate of DA, the General Appropriation Act (GAA) provides annual appropriations for FMR under the DA budget which will be used for the construction, repair and rehabilitation of FMR which will be directly released to the Department of Public Works and Highways;

"WHEREAS farm to market road from Sitio Lidong to Sitio Burin-ay, Barangay Cabugao, this Municipality needs to be constructed to benefit the social and economic interests of the residents in the area who are primarily composed of hanunuo mangyan; **Now, therefore, be it**


