“**WHEREAS**, Bulalacao, a 3rd class municipality with a population of 44,366 based on 2020 census, has 15 barangays and total agricultural land area of 10,325.80 hectares with 6,016 registered individuals employed in the agricultural sector, and has a tropical climate type conducive to planting of staple crops such as rice and corn including garlic, onions and varieties of vegetables and fruits being transported to Manila and nearby provinces;

“**WHEREAS**, during harvesting season in Bulalacao, the farmers are experiencing massive losses in their earnings because of the low commodity prices being offered to their products that could not compensate in the high cost of pesticides and fertilizers they spent;

“WHEREAS, it is ideal to have a cold storage building and machineries that can stored the products up to ten months without deterioration which the farmers can sell it in a later season where they can have a just and/or high commodity prices to properly pay off all their hard work and expenses;


“WHEREAS, a progressive agriculture is quite evident in Bulalacao but it is still striving for improvement and sustainability, its Local Government Unit understands the needs and circumstances of its farmers in providing best quality agricultural products without compromising their own income, thus the provision of cold storage building and machineries would certainly ensure Bulalacao farmers the confidence to produce more and will result to upholding the social economic status of the community as a whole; Now, therefore, be it...


