Salas regarding the rental of a water source by the First Party from the Second Party situated in Sitio Tulale, Barangay Maujao which supplies potable water to Barangays Poblacion and Campaasan in consideration of a monthly rental fee of six thousand pesos (PhP6,000.00) which commence on July 1, 2023 up to June 30, 2024;

**RESOLVED FURTHER, That:** Any change or alteration in the Kasunduan originally presented shall have no effect and therefore null and void;

**RESOLVED FINALLY, That:** Any legal encumbrance that may arise in the execution and actual application of this Kasunduan shall be the sole responsibility of the heads of Implementing Offices or Units;


